Requirement for Which Variances are Requested: The applicant wishes to erect a 7-foot by 14-foot deck to be attached to the front of the residence located at the above address, with a proposed front setback of 49 feet. The Town Code requires a minimum front setback of sixty (60) feet in the RR-80 Rural Residential District.

State Environmental Quality Review Determination: The granting of an Area Variance for an a 98-square-foot addition to an existing residential structure is classified as a Type II Action under Part 617.5 (c) (16) and (17) of the State Environmental Quality Review (SEQR) Regulations. Type II Actions have been determined, under the SEQR Regulations, not to have a substantial adverse impact upon the environment or are otherwise precluded from further environmental review under article 8 of the State Environmental Conservation Law (ECL).

County Planning Referral Recommendation: N/A. Exempt Action provided for in the Ontario County Planning Board Bylaws.

FACTORS CONSIDERED AND BOARD FINDINGS

Findings: The Zoning Board of Appeals (hereinafter referred to as the Board) finds that the residential character of this neighborhood is predominantly single-family dwellings fronting along a Town Highway and lying within a rural (low density) residential neighborhood. The Board further finds that the proposed deck is in keeping with the character of other dwellings in the neighborhood noting there are other nearby structures with front decks/porches. The Board further finds that the proposed deck is to replace existing concrete steps which are beginning to crumble and are creating an unsafe condition. The Board further finds that the proposed design for this building addition will complement the front elevation of the existing structure. The Board, based upon these findings, determines that the granting of the requested Area Variance will not create an undesirable change in the character of the neighborhood; or create a detriment to nearby properties.

2. Whether the benefit sought by the applicant can be achieved by a feasible alternative to the requested variance. YesX No
Findings: The Board finds that the existing structure is located fifty-six (56)-feet from the Front Lot Line of Hook Road and was constructed several years ago. The Board further finds that the proposed deck involves encroachment of eleven (11) feet into the Front Yard Area of the Lot and that this would leave forty-nine (49) feet between the front of the proposed deck and the Front Lot Line along Hook Road. The Board further finds that there are no other options available for installing a porch that is attached to the front of the residence without requiring the requested variance. Therefore, based upon these findings, the Board determines that the benefit to the applicant cannot be achieved by a feasible alternative design
3. Whether the requested variance is substantialYes _X_ No
Finding: The Board finds that the requested encroachment into the Front Yard Setback from Hook Road involves a variance of eleven-feet which is a variance of nineteen-feet which is a variance of 18.3% from that required by Town Code. The Board has consistently found that a variance involving fifty percent (50%), or more is a substantial variance.
4. Whether the proposed variance will have an adverse effect or impact upon the physical environmental conditions in the neighborhood or district. Yes _X_ No
Finding: The Board has given consideration to the criteria for determining significance, as set forth in Section 617.7 of the SEQR Regulations. The Board finds that the proposed Action is classified as a Type II Action under Section 617.5 (c) of the New York State Environmental Conservation Law (ECL), Article 8. The Board finds that Type II Actions have been determined not to have a significant adverse impact upon the environment and has thereby satisfied the procedural requirements of the ECL.
5. Whether the alleged difficulty was self-created which consideration shall be relevant to the decision of the board of appeals but shall not necessarily preclude the granting of the Area VarianceX_Yes No
Finding: The Board finds that the alleged difficulty is self-created due to the applicant's choice of wanting to

DETERMINATION OF THE ZONING BOARD OF APPEALS BASED UPON THE ABOVE FACTORS

The Zoning Board of Appeals, after reviewing the above five proofs, finds:

attach a deck, having the proposed size, to the front of the residence.

The Board based upon its review of the record on this application finds that the benefit to the applicant does outweigh any known detriment to the community or neighborhood; and, therefore, the requested area variance to erect an open-air deck with railing forty-nine (49) feet from the Front Lot Line of Hook Road instead of the required sixty-feet (60) is APPROVED with the following conditions:

- 1. The exterior of the porch addition is to match, to the extent practical, the exterior treatment of the existing structure.
- 2. The porch addition shall not be enclosed.
- 3. Any light fixture(s) to be installed as part of the proposed porch addition shall comply with the Town's Dark Sky lighting regulations contained in Chapter 165 of the Town Code.
- 4. A Building Permit shall be obtained by the applicant prior to the start of construction.

NOW, THEREFORE, BE IT RESOLVED that the Board in making this Determination has satisfied the procedural requirements under New York State Town Law and the Town of Farmington Town Code.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be provided to the Applicant and a copy of this resolution filed with the Town Clerk's Office.

BE IT FINALLY RESOLVED that the Board directs this Resolution be placed in the public file upon this Action and that a copy hereof be provided to the applicant.
